- 1. Call to Order/Roll Call/Agenda Review

5.1. Metro/Measure D

Daugherty reported that individual Commissioners reviewed and provided feedback on the proposed policy providing a fare waiver for community members living with legal blindness. Metro staff is reworking the policy based on community feedback. Daugherty will follow-up with Metro staff to determine if the Commission will be able to review the revised policy.

Molina and Staff met with County Parks leadership to draft an adaptive swim program proposal including group classes, one-on-one classes, and regular equipment safety checks by an outside vendor. Parks staff support the concept pending further exploration into associated costs and vendors. Staff is in contact with the Kerns Adaptive Swim Program in Monterey who will work with us to draft a phased implementation approach for consideration at the November meeting. The Kerns Board of Directors fully supports the collaboration. Implementation date is projected for late Spring/early Summer 2020.
