- 6.4.2. Covid-19 Vaccination Distribution

Commission discussed the County's vaccination rollout, County and State communications regarding identifying and prioritizing people with disabilities in the tier structure, and the need for more clarity and better representation in public health communications and policy related to vaccinations. Of concern is the need for people with developmental and intellectual disabilities to be vaccinated earlier because of their increased risk for serious complications and death should they contract COVID-19.
